

## **Input File Error Reference Tool**

**Last Revised:** 08/27/2020

Employers transmit their employee eligibility records via the following SHBP approved file layouts:

- 1. Add Update Files (AUF) submitted by Boards of Education and similarly situated Employers and Contract Employers, or
- 2. SAO PeopleSoft Files submitted by the State Accounting Office (SAO) on behalf of State Agencies and other Employers participating in SAO

When Employers transmit employee eligibility records to SHBP, sometimes those records error out, meaning the records cannot be processed and loaded in the SHBP Enrollment Portal. Employers are notified via an Input File Error Report automatically loaded in their "From\_ADP" folder in the "Input\_Errors" subfolder in the State Health Repository Tool (SHRT).

Each record included in an Input File Error Report includes a message code in column G.

Employers should cross reference that message code in column G with this Input File Error Reference Tool to determine the root cause of the error for the employee eligibility record on the file transmitted and the corrective action needed. Failure to resolve the error(s) will result in the employee eligibility record never being loaded in the SHBP Enrollment Portal which will impact the employee's coverage and multiple Employer reports, including but not limited to the Employing Entity Report, Premium Billing Report (BRP), and Affordable Care Act (ACA) Reports.
